Citizens of the Great City of Eureka,

Thank you for the opportunity to serve as your mayor for the past eight years. There have been ups and downs for sure, but we have been able to move forward on some really important items.

Number one, in my opinion, is the opportunity of every household in town to have natural gas in their home. It's been a long hard road, but we're finally there. I have talked to many of you who still have questions about what they need to do.

Many of you signed up to get natural gas to your home, but are unsure about what happens next. If you signed up, you received an estimate of the cost of running the gas line from the street to your home. It made it sound like you would have to pay that amount but that is only true if you wait more than two years to actually make the connection. You have all been told that Dominion Energy will run the gas to your home free of charge and that is true. What isn't as widely known is that in order to ensure that the hook-up meets state code and will not become a danger now or in the future, there needs to be an inspection. This inspection will be done by the

Eureka City inspector. You will need to have your contractor, if you are using one, or you can do this yourself, draw a schematic that shows the length and diameter of all piping within the home and turn it in to the city office so it can be forwarded to the inspector. Dominion Energy has probably already showed you where they are going to place the meter. Draw the schematic showing how you plan to get the gas from the meter to your appliances. If you need help to know the size of pipe needed or any other questions, call the city office and ask them to have a Dominion Energy representative come by and help you with these questions. If needed, they may even be able to relocate the meter. When you take the schematic into the city office, you will need to pay a fee of \$210.00. This is to cover the cost of the inspection. Please, do not contact the inspector yourself, all communication with the inspector should go through the city office.

Thanks again, and congratulations to all the newly elected city officials.

ORDINANCE NO. 05-14-2013-2

AN ORDINANCE ESTABLISHING WINTER PARKING RESTRICTIONS ALONG ALL CITY STREETS WITHIN THE EUREKA CITY LIMITS.

Be it ordained and enacted by the council of the City of Eureka, State of Utah as follows:

SECTION A - DEFINITIONS:

For the purpose of this section, "City Street" shall be defined as being from curb to curb or, being property line to property line.

SECTION B - STATEMENT OF PURPOSE:

It is the purpose of this ordinance to promote the public health, safety, and general welfare of the citizens of this community by preserving our ability to plow the winter snows and keep our roads safe for all to enjoy.

SECTION C - Unlawful to Park, Leave or Abandon:

It shall be unlawful to park, leave or abandon a vehicle on any portion of a City Street or right of way of a city street beginning November 1 to March 31. No parking at any time if there is any snow accumulation within the travel lanes regardless of date. Vehicles include but are not limited to automobiles, trucks, trailers, mobile homes, travel trailers, boats, buses, ATV's, snowmobiles, or any device used in the transportation of humans, animals, or freight of any kind.

SECTION D - Vehicles Subject to Tow:

Vehicles remaining on City Streets under these conditions are subject to being towed at owners' expense.

SECTION E - Penalty:

A violation of this Section will be considered a Class C misdemeanor.

This ordinance shall take effect immediately upon its passage and posting as provided by law.

Chicken & Dumpling Casserole

Total Time:

Prep: 30 min. Bake: 40 min.

Makes:

8 servings

Ingredients

- 1/2 cup chopped onion
- 1/2 cup chopped celery
- 1/4 cup butter, cubed
- 2 garlic cloves, minced
- 1/2 cup all-purpose flour
- 2 teaspoons sugar
- 1 teaspoon salt
- 1 teaspoon dried basil
- 1/2 teaspoon pepper
- 4 cups chicken broth
- 1 package (10 ounces) frozen green peas
- 4 cups cubed cooked chicken

Dumplings:

- 2 cups biscuit/baking mix
- 2 teaspoons dried basil
- 2/3 cup 2% milk

Directions

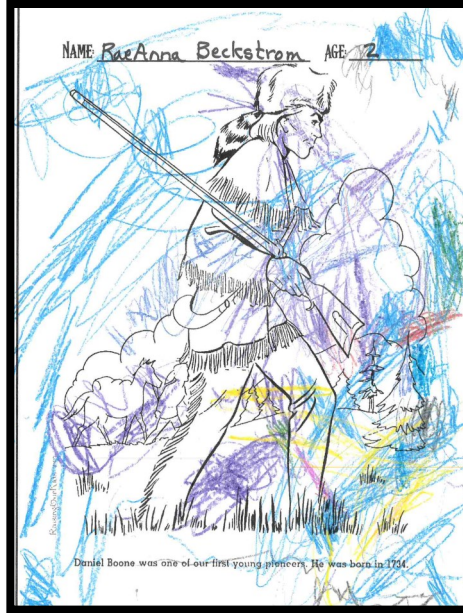
1. Preheat oven to 350°. In a large saucepan, sauté onion and celery in butter until tender. Add garlic; cook 1 minute longer. Stir in flour, sugar, salt, basil and pepper until blended. Gradually add broth; bring to a boil. Cook and stir 1 minute or until thickened; reduce heat. Add peas and cook 5 minutes, stirring constantly. Stir in chicken. Pour into a greased 13x9-in. baking dish.
2. For dumplings, in a small bowl, combine baking mix and basil. Stir in milk with a fork until moistened. Drop by tablespoonfuls into mounds over chicken mixture.
3. Bake, uncovered, 30 minutes. Cover and bake 10 minutes longer or until a toothpick inserted in a dumpling comes out clean.

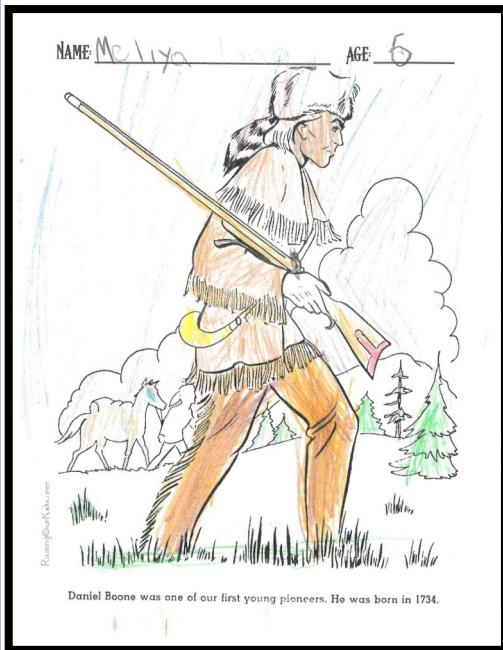

- Government issued picture ID.
- Social Security cards for you and EVERYONE living in your household.
- A copy of your power, heat and water bills.
- Proof of ALL income received by all household members in the month prior to the month of your application.
- Proof of any eligible medical expenses, child support and alimony you paid in the month prior to the month of your application.
- Proof of disability, if applicable.
- Proof of birthdate for a child age six (6) or under.
- Additional documentation, if required.



