It's that time of year again when we are getting ready for our town celebration the "*Tintic Silver Jubilee*" that will be held August 14-15, 2020, in Eureka, Utah.

We are contacting all businesses within Eureka and the surrounding areas to invite them to take part in our celebration and support the Tintic Silver Jubilee Committee and Eureka City, by either being in the parade, setting up a vendor booth at our City Park or along our Historic Main Street on Saturday, August 15th, sponsor an event or make a donation.

Our parade is a one of a kind, short and sweet parade that allows businesses, ballteams, organizations, etc. to advertise as well as show their support for the town. The parade is the perfect opportunity to advertise for your business. You can have someone walking or riding bikes, ATV, in Cars, or on a float, displaying signs, handing out coupons, etc.

Vendor booths are available at our City Park or along Main Street to sell food, clothing, art, homemade goods, etc. at a cost of \$25.00 for the temporary business license. If you currently have a commercial business license issued by Eureka City, and would like to have a sidewalk sale in front of your business; or a home business and would like to set up in one of our booth spaces at the park, you will not need the temporary license, but you must contact the committee to let them know you will be selling.

You may also be interested in purchasing a banner to be put on display during the celebration. These banners not only help support our celebration, but is great advertisement for your business. The price for a new banner is \$300.00. If you have already purchased a banner in a previous year, there is a small fee of \$50.00 for renewal for it to be displayed this year.

Donations can be an item for our raffle or a monetary donation to help with the costs of the events we are sponsoring such as the Ice Cream Social, and much more.

Eureka City News

June has been a busy month for the City. The City Council passed several Resolutions at their meetings: one was to Amend the Budget for the Fiscal Year Ending June 30, 2020, one to adopt a Budget for the Fiscal Year Ending June 30, 2021, and the last one was to impose Fire Restrictions throughout town. They also passed an Impact Fee Ordinance. Each Resolution is posted in the Legal Section of this newsletter along with a summary of the Impact Fee Ordinance. You may also go to the City Website, eurekautah.org, to view the entire resolutions and ordinance, or stop in the office during regular work hours, 8:30 am to 5:00 pm, Monday through Friday.

ANNUAL DRINKING WATER REPORT

Eureka City also completed their Annual Drinking Water Report (Consumer Confidence Report) for 2019. To access the report, a link was provided on June's City Service Bill. For residents that do not have access to a computer/internet, you may contact the City Office to have a copy mailed to your address. Copies of the report are also available in the City Office.

TINTIC SILVER JUBILEE

The Tintic Silver Jubilee is still scheduled to take place August 14th-15th. For anyone planning an event, please contact the City Office or any of the committee members to try and coordinate your event as part of the celebration. Anyone wanting to be in the parade, forms are available in the City Office. Vendor applications are also available. Any donations for our raffle are very much appreciated.

Due to the CDC's and Health Department Regulations, Juab County is still in the yellow phase which requires that we still need to practice social distancing, wear masks where social distancing can't be accomplished, disinfect areas of high use and wash hands regularly.

Watch for the event flyers to come out by the end of July.

LICENSING & PERMITS

Building Permits - Eureka City has posted in the past several editions of the newsletter concerning residents needing building permits. As a city, we love to see residents taking pride in their home and their yard, by renovating, repairing, or building new; but the State Law requires that Building Codes be followed, and Eureka City has adopted the State Building Codes. These regulations are for the safety and protection of the citizens. We are still seeing building taking place around town, some with and some without permits. We are also seeing posts through social media on remodeling or adding on to homes taking place. If you have a project you would like to do, please contact the City Office prior to doing any of the work.

Business Licenses - *All businesses need a City Business License*, whether in the home or in the business district in town. It is illegal to operate or be open for business until all requirements have been met. Anyone owning or operating a business without a permit is subject to fines and forfeiture of your business.



RESOLUTION NO. R-06-25-2020-3

A RESOLUTION OF THE EUREKA CITY COUNCIL ADOPTING FIREWORKS RESTRICTIONS:

WHEREAS Eureka City wishes to protect vulnerable areas from the risk of fire; and

WHEREAS Eureka City wishes to support the Fire Department's efforts to limit the risk of fire;

WHEREAS the Eureka City fire code officials determine that existing or historical hazardous environmental conditions necessitate controlled use of fireworks,

NOW, THEREFORE, BE IT RESOLVED BY THE EUREKA CITY COUNCIL as follows:

SECTION I: POLICIES REGARDING FIREWORKS.

- A. All aerial and non-stationary fireworks, i.e. ground flower types, are prohibited inside and within 200 feet of the highlighted areas of the restrictions map, and within 200 feet of any undeveloped lot or vacant building with dry vegetation.
- B. All fireworks and aeriels are prohibited in city parks and all other city-owned properties.
- C. Fireworks are prohibited within twenty-five (25) feet from any building.
- D. The City Fire Chief, County Fire Marshal, or designee, reserves the right to restrict fireworks or recreational burns in any high-risk geographical area inside Eureka City that may be at risk or has a potential public safety concern.


SECTION II: SEVERABILITY.

The sections, paragraphs, sentences, clauses, and phrases of this Resolution are severable. If any such section, paragraph, sentence, clause, or phrase shall be declared invalid or unconstitutional by the valid judgment or decree of a Court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any of the remaining sections, paragraphs, sentences, clauses, or phrases of this Resolution.


SECTION III: EFFECTIVE DATE.

This resolution shall take effect immediately upon its approval and adoption.

Eureka City, Utah Ordinance No. 06-25-2020-1

ORDINANCE ADOPTING IMPACT FEE ANALYSES AND IMPOSING CERTAIN IMPACT FEES FOR: WASTEWATER, WATER, AND PARKS, RECREATION, TRAILS AND OPEN SPACE; PROVIDING FOR THE CALCULATION AND COLLECTION OF SUCH FEES; PROVIDING FOR APPEAL, ACCOUNTING AND SEVERABILITY OF THE SAME, AND OTHER RELATED MATTERS.

Recipe Corner

Barbecued Picnic Chicken

Total Time

Prep: 15 min. Grill: 45 min.

Makes

8 servings

Ingredients

2 garlic cloves, minced	1 tablespoon celery seed
2 teaspoons butter	1 tablespoon prepared mustard
1 cup ketchup	1/2 teaspoon salt
1/4 cup packed brown sugar	2 dashes hot pepper sauce
1/4 cup chili sauce	2 broiler/fryer chickens (3-1/2 to 4 pounds each), cut up
2 tablespoons Worcestershire sauce	

Directions

- In a large saucepan, saute garlic in butter until tender. Add the next 8 ingredients. Bring to a boil, stirring constantly. Remove from the heat; set aside.
- On a lightly greased grill rack, grill chicken, covered, over medium heat for 30 minutes, turning occasionally. Baste with sauce. Grill 15 minutes longer or until a thermometer reaches 170°, basting and turning several times.

Test Kitchen Tips

- This sauce is best when made a day or two in advance, giving the flavors time to come together.
- If you don't have chili sauce on hand, you can use 1/4 cup extra ketchup or 1/4 cup cocktail sauce.
- Try this cool-guy move if you don't have a basting brush: Tie a few sprigs of rosemary or another hearty herb together with twine, then baste with it.

- 1 carton (8 ounces) frozen whipped topping, thawed

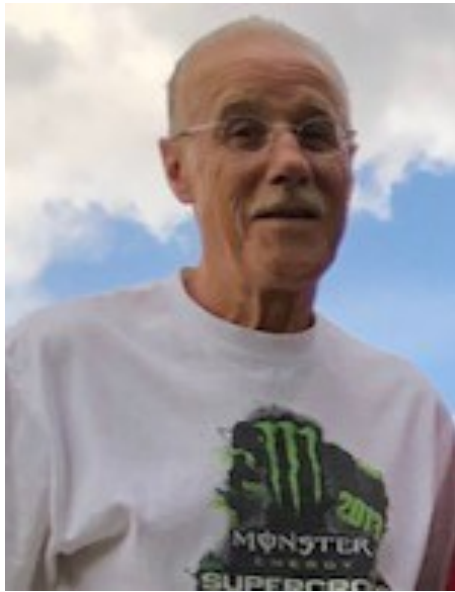
Directions
